To join us even if to sit on the side and watch. If a chair happens to be empty, we would be honored if you


Elect to help and fill it. We welcome all... new masons, old masons... even "rusty" or "crusty" ones. Come out

### Just Wondering

"In commemoration of so sublime an event I masonically say: Let there be light." I was studying the Fellowcraft degree so that I could help with our ritual practice on Thursday nights and this phrase from the degree began to haunt my thoughts. I believe I've been a Mason for somewhere around 15 years. In all this time it has never occurred to me that in each of our degrees the candidate/brother is hoodwinked for a large part of the degree. I would estimate (I don't' really know) that if I exclude the Master Mason degree then our candidate/brother is hoodwinked for 30% - 40% of the ritual. If I include the Master Mason degree, then the percentage that a candidate/brother is hoodwinked is even greater. Ruminate upon that reality for a moment. A candidate/brother is hoodwinked for a large percentage of all the degrees and additionally, the candidate/brother has never heard the ritual of each of the degrees that are being conferred! With this understanding in hand I had to ask myself a couple of questions and I ask these same questions of everyone who has taken the time to read my article: If the candidate/brother is hoodwinked then does it matter which direction I walk in i.e. how I conduct myself during ritual? Even more, do the words I speak even matter? After all, since we are doing this degree for the candidate/brother why shouldn't we be able to simply read the ritual from our manuals and conduct him through the Lodge in the most expeditious manner possible? He can't see us and at best, the candidate/brother is spotty with regards to spoken ritual; it doesn't make sense that it is forbidden to read the ritual manuals or move in any fashion we would like during a degree. When a candidate/brother is hoodwinked then memorization of ritual for the sake of the candidate/brother is not efficient - and neither is the dance we conduct through the Lodge. Considering the latter, I lay the following question on the table for all who read this article: To what purpose do we memorize ritual, spoken or otherwise? Is it all for the candidate/brother?

## Registration Procedure for Electronic Balloting Deadline Friday, April 5<sup>th</sup>

Per C&L, Past Masters (PM) may cast their ballots for elected Grand Lodge offices (Title 3, Article IV, Section 2, Part 1) using an Internet connection. This article will outline the process you must follow in order to vote at a location other than the Balloting & Registration Room at the Annual Communication in Atlantic City. You may vote from any device (desktop, tablet, mobile) that has an Internet connection and Web browser.

#### YOU MUST REQUEST AN OFF-SITE BALLOT by PRE-REGISTERING.

To pre-register, you must send an email by 11:59pm Eastern Time, Friday, April 5<sup>th</sup>, 2019 to GLNJVOTING@GMAIL.COM containing:

- Your full name
- Your email address
- Your Member Number (found on your dues card or through your Lodge Secretary)
- NJ Lodge Name/Number
- Your Phone Number

Once your eligibility is verified by the GL office, you will receive a confirmation email stating that you have successfully registered. Then, on the morning of Wednesday, April 17th, you will receive an email with an encrypted link that will take you to the appropriate webpage to vote. This email will also contain additional information and instructions. Remember, registration for off-site voting will close at 11:59pm Eastern Time on Friday, April 5th, 2019.

Balloting will be open from approximately 12:00 noon on Wednesday, April 17th until sometime between 9:00am and 10:00am Thursday, April 18th (all times Eastern). Once balloting starts, an email will be sent to those who have registered reminding them that the ballot is now open. Offsite balloting may be done at ANY TIME while balloting is open in Atlantic City. Please note that the times for the start and end of off-site voting are variable depending on when the Grand Master starts and stops balloting on-site. Off-site balloting will end at the same time as on-site balloting. Please do not take a chance and wait until the last minute – vote any time before 9:00am Thursday!

You may request an off-site ballot if you are a PM of any lodge in a recognized jurisdiction and a member in good standing of a Lodge under the jurisdiction of the Grand Lodge of New Jersey, F&AM. Please note that the WM, SW and JW must cast the vote assigned to their office on-site (per C&L). If the WM, SW or JW is also a PM (previous year) and they are not able to attend the Annual Communication, they may only cast their PM vote off-site and must follow the procedure above to register for that ballot.

My Brothers,

When I was running to serve as your Junior Grand Warden in 2015, I promised you that if elected, I would strive to bring transparency to the brethren concerning the finances of our Grand Lodge. Almost two years ago, I proposed legislation that was adopted, mandating the publishing of the audited Grand Lodge finances. After numerous months, once all the paperwork was completed, the final report of the independent auditor has been received and the findings are startling. I held a meeting on Friday, March 8, 2019 with the independent auditor, the elected line, Grand Lodge office administrator, Acting Grand Secretary, President of the Grand Lodge Board of Trustees and the audit committee. The purpose was to review the independent auditors report.

It goes without question that for some time, there has been questions related to the finances of the Grand Lodge, to which before I even served as a member of the progressive elected Grand Line, I shared in your concerns. Now as your Grand Master, I believe it is my Masonic and fiduciary responsibility to report to you on our findings.

In reviewing the internal audit of our Grand Lodge records, there was a concern that money from the Grand Lodge was owed to the Masonic Charity Foundation of New Jersey ("MCF"); however, there was no clarity as to the extent of how much the Grand Lodge owes the Foundation until this past week when the final independent audit report was provided. Although the independent audit has confirmed that our past-due pass-throughs to The George Washington Masonic National Memorial, New Jersey DeMolay and New Jersey Rainbow for Girls were fully satisfied, it has been determined that the Grand Lodge has not been current on its pass throughs to the MCF. Specifically, as per the independent audit, as of April 30, 2018, the Grand Lodge owed the MCF the sum of \$393,728.00, which consists of unpaid home fees for initiates in the amount of \$117,505.00 and for home maintenance fees in the amount of \$276,223.00. The pass-throughs are the donations collected through your dues payments which are part of the Grand Lodge assessment. These donations are earmarked for the Masonic Charity Foundation,

Rainbow, DeMolay, HTMT and George Washington Memorial. You pay them through your dues which in turn, your lodge remits to the Grand Lodge yearly with its annual return. For several years, these donations were not fully passed through to Charities. The minutes of the Grand Lodge trustees reflect the elected line and I, when given reports of the deficiencies, demanded that they be fully paid. We can only demand the arrears to be paid which we were made aware of. The reports were conflicting. Originally, we were told we were up to date by the Grand Lodge office as the minutes of the Grand Lodge Trustees reflect. We were informed that Rainbow, DeMolay were paid their delinquent pass-throughs. On 6/27/17 the George Washington National Memorial was paid \$164,261.00 of delinquent pass-throughs, Just recently the HTMT was brought current. I questioned the monies due the Masonic Charity Foundation and was told by the Grand Lodge office they did not know why Grand Lodge IRS filing of the 990 in 2016 showed \$280,709 as owed to the Foundation. My Brothers, the audit by an independent professional auditor shows the Grand Lodge owes \$393,738.00 as of the date of this letter to you! This is from years of partial payments and, lately nonpayment, as of April 2018. The auditor used the actual amounts paid through your lodges' annual returns and compared these annual payments to the payments made/passed through to the Charities by the Grand Lodge office.

My brothers, this is unacceptable and the MCF must be made whole immediately. There is a potential issue with the IRS if we don't. Our 501c10 status is at risk. The Grand Lodge simply does not have sufficient money in its general operating account available to pay the balance due the MCF. Indeed, nor does the Grand Lodge budget committee can anticipate a surplus anywhere close to that size next fiscal year to satisfy the balance due the MCF.

In light of the foregoing, I am calling a Town Hall Meeting for, April 5, 2019 at 7:00 P.M. at the Fellowship Center, located at Masonic Villages at Burlington, NJ. The purpose of this Town Hall is to present to you in greater details the results of the audit, and to discuss options to immediately address this deficit. In order for you to be properly informed as to the finances of the Grand Lodge in preparation for the annual communication on April 17-18 and the potential pieces of legislation that will have to be adopted at that session to address this significant deficit due MCF, it is necessary that the Town Hall occur prior to the annual communication.

Lastly, your progressive elected grand line and I are further considering other protective measures for compliance purposes to ensure that this never occurs again. Those will be discussed at great length soon. I encourage your active involvement in the discussion as we work together to resolve this
